

**UHRICHSVILLE CITY COUNCIL**  
**Thursday, August 14, 2014**

Council President Mark Haney called the meeting to order at 7:00 p.m.

ROLL CALL showed the following members present: Mr. Grandison, Mr. Baker, Mrs. Mick, Mr. Peterson, Mr. Warner, Mrs. Davis, Mrs. Cottis.

The Pledge of Allegiance was led by Council Clerk Amy Myers.

A motion was made by Mrs. Cottis to accept the minutes from the July 24, 2014 regular Council meeting; 2nd by Mrs. Davis; ROLL CALL: Mrs. Cottis-yes; Mrs. Davis-yes; Mr. Grandison-yes; Mr. Baker-yes; Mrs. Mick-yes; Mr. Peterson-yes; Mr. Warner-yes.

Council President Mark Haney said we would be going out of order welcome David Held, from the Stark-Tuscarawas-Wayne Joint Solid Waste Management District. Mr. Held said he was asked by Council Woman Gayle Mick to come and speak about recycling. Mr. Held says he supports curb recycling, based on population the city may get back \$25 per ton and curb side is most effective way especially if you have containers. Mr. Held said you would have one company in town which means one truck one day pick up, most townships are gearing toward 1 company. Mr. Hillyer said the money get be used additional containers, a newsletter. Mr. Held said he isn't here to endorse one company over another but to endorse recycling.

**ADMINISTRATIVE REPORTS:**

**Mayor Terry Culbertson:**

- Re-appointing Wally Hines to the water board for 3 years.
- For the month of July there were 13,794 people at the waterpark this doesn't include private parties.
- New banners are up on Water Street and they were paid for by each individual company.

**City Services Director Joe Bollon:**

- He has a purchase requisition from the fire department that he gave a copy to the Council Clerk. The amount is for \$1684.70 for tools. He needs council to approve the requisition since it is over the \$1000 cap. A motion was made by Mr. Baker to approve the requisition with a 2nd by Mrs. Cottis. ROLL CALL: Mr. Baker-yes; Mrs. Cottis-yes; Mr. Grandison-yes; Mrs. Mick-yes; Mr. Peterson-yes; Mr. Warner-yes; Mrs. Davis-yes.
- Mr. Bollon would also like council to increase the cap of spending from \$1000 to \$5000; Mr. Grandison said it is in Finance Committee for discussion.
- There was a sink hole issue on Eastport in front of Maculatis's house; called Verizon, been replaced and at their cost. Mrs. Cottis asked where are we with the Eastport project? Mr. Haney spoke to Quicksall and they are moving forward with Grant applications.
- Mr. Bollon asked that we have a Storm Sewer meeting next month.
- Mr. Bollon asked Mr. Warner if he had an update on the viscous dog? Mr. Warner said no.

**Assistant Law Director Brett Hillyer,** Working on building codes and sent out letters, next step will be court action.

- Setting up a meeting for those properties that haven't paid their taxes.
- Has a request from Attorney Ong who is the Attorney for the estate of Hudson Hillyer; donating 3 parcels to the city and are up to date with their taxes; 4-5 Acres; probably should appoint special council since he is the grandson of Hudson Hillyer.
- Sorry he wasn't here for the last meeting but he wanted to clarify some things; Mr. Hillyer handed out to council different court cases which gives the city statutory authority to the city; the court cases outlined show precedence's and is urging council to pass this tonight. He spoke to Commissioner Everett and she is for curbside recycling. Reviewed the bid by Sugarcreek that was awarded to Kimble. He has heard from several residents and they have mispoken. In his opinion this is very good trash program and urging council to move forward. Mr. Peterson asked if you could make changes to contract before signing? Mr. Hillyer said the street names and pick

up sites could be changed. There are 2 sources of income for the city the \$20 per ton from Kimble and \$25 per ton from Joint Waste.
