# UHRICHSVILLE CITY COUNCIL Thursday, February 13, 2014

Council President Mark Haney called the meeting to order at 7:00 p.m.

ROLL CALL showed the following members present: Mrs. Davis, Mr. Peterson, Mrs. Mick, Mr. Baker and Mr. Grandison. Let the record show that Mrs. Cottis was absent, she has parent teacher conferences.

The Pledge of Allegiance was led by Council Clerk Amy Myers.

A motion was made by Mrs. Davis to accept the minutes from the January 23, 2014 meeting; 2nd by Mr. Peterson; ROLL CALL: Mrs. Davis-yes; Mr. Peterson-yes; Mr. Grandison-yes; Mr. Baker-yes; Mrs. Mick-yes.

Swearing in of new Council Member Terry Warner; Law Director Brett Hillyer swore in Mr. Warner and read his oath of office. Council President Mark Haney wanted to welcome Mr. Warner; Mr. Warner said it is an honor to be here.

Council President Mark Haney said a President Pro-Temp needs to be elected this evening; Mr. Peterson nominated Mrs. Cottis; Mr. Haney said he couldn't because she was not present; Mrs. Davis nominated Mr. Peterson with a 2nd nomination by Mr. Grandison; Mr. Peterson declined the nomination; Mrs. Mick asked if this needed to be done tonight and Mr. Haney said yes; Mr. Peterson nominated Mrs. Davis with a second nomination by Mrs. Mick; Mrs. Davis accepted the nomination; Mr. Haney said nominations were closed. ROLL CALL: Mr. Grandison-yes; Mr. Baker-yes; Mrs. Mick-yes; Mr. Peterson-yes; Mr. Warner-yes; Mrs. Davis-abstain.

Mr. Haney said the minutes from the Emergency Council meeting of January 27, 2014 need to be accepted; a 1st motion was made by Mr. Grandison; a second by Mrs. Davis; ROLL CALL: Mr. Grandison-yes; Mrs. Davis-yes; Mr. Baker-yes; Mrs. Mick-yes; Mr. Peterson-yes; Mr. Warner-yes.

Council President Mark Haney asked any of the visitors if they had to leave right away because he has moved the visitors portion of the meeting to the end, John Ney, World Energy explained he would like to present now. Mr. Ney is here to discuss Aggregation Program for electric. Handed out a sample ordinance and FAQ's; the next ballot date available is November 6, 2014; explained aggregation bring down costs on utilities for residents of the city; he spent some time with the auditor a few years ago; did this at the Village of Carrollton; if the resident has a 3rd party supplier have to wait until that contract is up and PIPP program residents are not eligible. Mr. Haney asked if this is for electric only? Mr. Ney replied he can do both electric and gas.

# ADMINISTRATIVE REPORTS:

Mayor Culbertson: Fire captain's exam will be Monday, March 3, there are 2 candidates.

- Had a Park Committee meeting on January 28.
- Attended and oil and gas meeting, January 31, TOGA; 4 hour meeting; 9 speakers and one speaker spoke about JEDD.
- Received a thank you letter from the Village of Dennison, from the Mayor Tim Still; he thanked us for our help as their plow trucks both broke down; we plowed around the hospital and other areas for them.
- Received a report from the courthouse on money we receive from them; 2009/\$10611.50; 2010/\$12720; 2011/\$12466.30; 2012/\$17375.71; 2013/\$17244.73.
- Had a phone call from ODOT/Omar Odohl AJar; they will offer inspecting our bridges free of charge; Mayor will not accept until we get this resolved with the county; could cost between two to three thousand for inspections and that doesn't include maintenance.

# City Services Director, Mr. Bollon:

- Big kudos to our street department; our streets were cleared as well as any other community.
- Requesting council purchase a Dura Patcher machine from the county. The cost is \$12,000 and would save the city money; Mr. Haney has been talking to Joe Bachman; the Mayor said that between 8th and Main streets we had used this machine and the patches are still there; We have used 7 tons @ \$95 per ton this year of the mix; New machine would cost between \$65,000-\$70,000; this one is in good shape and asking for council's approval; Mr. Haney said there are 4 other entities waiting to purchase but we have first choice; Mr. Bollon said we have already spent \$2800 on cold patch and probably been plowed out of patch; Mrs. Davis asked which line item and Mr. Bollon said the money is there according to our Auditor;

The Mayor wanted to remind everyone about the 1/4% income tax increase on the ballot in May and to please promote. Mr. Peterson said in 2009 we received \$278,905 and in 2103 we received \$118,000 from the state. The Mayor said for a family earning \$50,000 the income tax is only \$125/year; and for a family earning \$10,000 the income tax is only \$25/year. The Mayor said the new police cruisers that one was purchased with a grant and the other with a lease.
