Council President Pro-Temp Bob Baker called the meeting to order at 7:00 p.m.

Council President Pro-Temp Bob Baker went out of order and recognized Dan Risko from the State of Ohio. Mr. Risko was there to make a presentation of the Ohio Checkbook Program. It is an interactive website that became available in 2015 for local governments use. 750 local governments are now using the website including cities, villages, township, and schools. Mr. Risko presented a demonstration showing that you can make a search of a category, for example equipment, and the website will show all expenditures for equipment. All of the information would be taken from the accounting software that is already used by the City and the technology is free to the City. The Ohio Checkbook Program would build the website. It is a great tool for council, administrators and tax payers to look at expenditures made by the City. Auditor Julie Pearch was asked how she felt about the program and she said she was skeptical at first but felt that it would be a good tool for the City. Mrs. Pearch would email her reports to the administrator of the website on a monthly or quarterly basis and the administrator would update the website. Mrs. Davis said that she gave her blessing.

A Resolution is also necessary designating the First National Bank of Dennison as the City's depository. The Resolution has a five year maximum with a cap of 2.5 million.

The storm sewer project wasn't completed and will be no greater than \$10,000.

Rita McPeak will pay for any enhancements to her project not covered by the contract.

The next Finance Committee Meeting with be August 17, 2016 at 6:30 p.m. and is open to the public.

Mr. Baker said that there will be stop-signs by 2018 and that Jeff Galbraith is buying some as we go. Mr. Bollon stated he didn't believe the project would be done before school started on August 25, but that the bus route would be dealt with as it was in the spring.
