# UHRICHSVILLE CITY COUNCIL Thursday, December 22, 2016

Council President Pro Tem Bob Baker called the meeting to order at 7:00 p.m.

## **VISITOR:**

Don Quicksall of Quicksall and Associates was in attendance and was asked to speak first. He presented Council with the General Engineering Agreement for review and consideration. Nothing has changed in the contract except some names and dates and the agreement has the same conditions as last year. Basically it states that Quicksall would be on call when needed and act as the city's engineers without being on the payroll. Last year Quicksall invoiced nothing to the city. The contract is used for funding work. If the city pursues a project, Quicksall will do the application and paperwork and there is no charge if the city doesn't qualify for the funds. If the city does, Quicksall's fees are rolled into the funding. It is not a binding contract and can be terminated at any time. The contract runs from January to January. The contract will be forwarded to the Law Director for his review and recommendations. Mr. Peterson asked if the staff of Quicksall would stay the same and Mr. Quicksall replied that there are no plans for staff changes. Mr. Peterson has stopped at Quicksall and they have made themselves available for any questions or concerns. The contract does not need to be accepted by the end of the year.

## Mayor Rick Dorland:

- Would like to remind city residents that there is a snow parking ban in effect anytime there is more than three inches of snow, vehicles are to removed from the street.
- Needs council members to be appointed as Volunteer Peace Officer's Dependants Fund. Mr.
   Miller and Mr. Warner agreed to be appointed again for 2017.
- The OWPC funding of Eastport Phase II project was denied based on a couple of factors. This
  will push the project back another year. Will reapply in the future.
- The representatives of the Little League applied to the Reeves Foundation for a grant and received \$53,000+ for upgrades to the Little League concession stand, press box, fencing and field.
- Has the Water Department's activities report in his office and anyone can review it if they wish.
- The Storm Sewer meeting next month may be lengthy and suggests that it be held earlier or on another day.
- Will be meeting on December 28, 2016 with representatives of Digital Marketing to finalize the city's website upgrade and it will be launched January 1.
- Considering next year a four-way stop at 8<sup>th</sup> and Water. It will be looked into and discussed with the Chief of Police and Law Director.
- Considering possibly enacting a false alarm ordinance. The fire department had a lot of alarms
  from a particular business last year (17). Every alarm call can be expensive. Not discouraging
  from having alarms. Has reviewed Alliance's ordinance and after three alarms they charge for
  the call. It will be on the back burner for now.
- Wished everyone a Merry Christmas and Happy New Year.

Mrs. Cottis suggested that the Storm Sewer meeting be held Thursday, January 5, 2017 at 6:00 p.m. and all were in agreement.
