The meeting was turned over to Joel Decker and Mandy of Regional EMS, Inc. They handed out a copy of their proposal to all who requested it. Their proposal included the price of \$18.00 per person per populous. They gave a presentation and opened the floor for questions

- Q: Buck Cottrell: Where will your trucks be housed?
- A: Close to Uhrichsville/Dennison. Looking at a garage at McCauley Drive area.
- Q: Wes Dillon: How many paramedics do you have?
- A: 2 at the present and hiring 3.
- Q: What kind of contract term are you looking for?
- A: One to three years. Probably three years would be best.
- Q: How long have you been in business?
- A: Since May.
- Q: What does your fleet look like?

A: We have three trucks. Two are in service and a third one will be going into service and we're looking at needing an additional two units. We're looking to purchase some equipment that we need.

Q: At meeting in June you brought up you need up front money. Do you still require that?

A: We would look at that. We need at least one more truck.

We are a non-profit company run by a Board of Directors. Board members are Charles Decker, Michelle Young and Orange Twp. and Monroe township will get their seat members by January.

- Q: Would you send a unit if the Village has an event?
- A: Sure. We would be more than willing.
- Q: Would your five paramedics be just for this area?

A: Just for this area.

Regional EMS was thanked for their presentation and left the meeting at this time.

Mayor Dorland asked what the next step was. Mr. Baker said there will be a meeting between everyone, Townships, Village and City.

At this point there was a long discussion between the parties.

It was determined that another meeting is scheduled for January 13, 2020 at 6:00 p.m. with the Townships and Village of Dennison coming with numbers so that final negotiations can be made.
