

UHRICHSVILLE EMERGENCY RESOLUTION 1698  
A RESOLUTION PROVIDING FOR ACCEPTANCE OF THE RUSH TOWNSHIP AND  
UHRICHSVILLE JOINT ECONOMIC DEVELOPMENT DISTRICT CONTRACT IN ITS  
PRESENT FORM, AND FOR A PUBLIC HEARING ON THE CONTRACT.

WHEREAS, the Council of Uhrichsville, Ohio, met in special session on August 22, 2013, commencing at 6:30 o'clock P.M., at the Uhrichsville city building in the council chambers; and

WHEREAS, council wants to express its support for the proposed Joint Economic Development District (JEDD) with Rush Township, Tuscarawas County, Ohio; and

WHEREAS, council wants to schedule this matter for a public hearing to receive and obtain required public input prior to adoption of the JEDD with Rush Township; and

WHEREAS, the Township of rush (the "Township") and the City of Uhrichsville (the "City") have negotiated and intend to enter into the Rush Township - City of Uhrichsville Joint Economic Development District Contract (the "Contract") to create and provide for the operation of the Rush Township - City of Uhrichsville Joint Economic Development District (the "District") in accordance with Section 715.72 of the Revised Code for their mutual benefit and for the benefit of their residents and the State of Ohio (the "State"); and

WHEREAS, this action will enhance the health, safety, and welfare of the people of the City of Uhrichsville.

NOW THEREFORE BE IT RESOLVED BY UHRICHSVILLE COUNCIL:

1. The Uhrichsville Council hereby approves the form of the Contract now on file with the Uhrichsville Mayor's office and Uhrichsville Council Clerk subject to any revisions thereto following the public hearing provided for herein and to final approval by this Council.
2. The City of Uhrichsville shall hold a public hearing concerning the Contract commencing at 6:00 p.m. on September 26, 2013 at the Uhrichsville Council Chambers, Uhrichsville City Building located at 305 E. 2nd Street, Uhrichsville, Ohio 44683. The public hearing shall allow for public comment and recommendations on the proposed Contract. The City may include in the Contract any of those recommendations prior to final approval of the Contract. The Council Clerk is authorized and requested to cause notice of the time and place and the public hearing to be published in the Times Reporter, which is a newspaper of general circulation in the Township, 30 days prior to the public hearing.
3. The Council further directs that a copy of the text of the Contract, together with copies of the District maps and plans related to or part of the Contract, shall be on file, for public examination, in the office of the Uhrichsville Mayor and the Uhrichsville Director of Public Services.
4. That this Council finds and determines that all formal actions of this Board concerning an relating to the adoption of this resolution were adopted in an open meeting of this Board and that all deliberations of this Board and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.
5. That this resolution is hereby declared to be an emergency measure necessary for the preservation of public peace, health, and safety for the City of Uhrichsville and its inhabitants, and provided it receives the affirmative vote of two-thirds (2/3) of the members appointed or elected to Council, it shall take effect and be in force immediately upon its passage and approval; otherwise, it shall take effect and be in force from and after the earliest period allowed by law. The resolution is needed on an emergency basis to meet the required publication and notice requirements of Ohio Law
