## UHRICHSVILLE EMERGENCY RESOLUTION 1699

AN EMERGENCY RESOLUTION TO SHOW SUPPORT FOR HIGHLY QUALIFIED AND MOST EFFICIENT UNION WORKERS AND EXPRESS COUNCIL'S DESIRE TO HAVE THE SAFEST AND BEST FACILITIES IN THE OIL AND GAS INDUSTRY BUILT BY THESE INDIVIDUALS WHO HAVE MET THE MOST RIGOROUS STANDARDS THROUGH PARTICIPATION IN AND GRADUATION FROM UNION APPRENTICE SHIP AND TRAINING PROGRAMS.

WHEREAS, the oil and gas industry is expanding its drilling, pipeline, infrastructure and construction in the vicinity of Uhrichsville, Ohio to service the extraction of oil, natural gas and other volatile compounds from the Utica and Marcellus shale formations; and

WHEREAS, the industry needs and desires to construct its pipelines, infrastructure with efficiency, while meeting the highest safety standards; and

WHEREAS, Union tradesman have undergone extensive training and have the knowledge, experience and wherewithal to construct these facilities in an economical, safe and efficient manner; and

WHEREAS, Union labor supplied for these projects will be supplied from the highly qualified local tradesman who are available for this work; and

WHEREAS, these local tradesman and their earnings will support the local economy through the expenditure of monies in local establishments and support local governments through the payment of tax revenues on those earnings; and

WHEREAS, union tradesman have supplied labor that has resulted in the construction of complex facilities in such a manner that the greatest efficiencies were realized and the facilities met the highest safety standards while the construction costs were competitive with less qualified and not as highly trained other workers; and

WHEREAS, the use of such qualified labor will support the industry and at the same time insure that the safest and best facilities are built and maintained for the great welfare of all.

## NOW THEREFORE BE IT RESOLVED BY UHRICHSVILLE COUNCIL:

I.

This council and Administration through the passage of thi resolution demonstrate their belief that Union Workers, well trained through apprenticeships and ongoing educational training programs, will construct through the use of these tradesman highly efficient, safe, and economic facilities and infrastructure that will result in fostering and furthering the greater good. Safe, efficient and well-built facilities will enhance the health, safety and welfare of the citizens of the city of Uhrichsville as well as the surrounding area to the mutual benefit of the industry, the people of Uhrichsville and the surrounding communities.

II.

That this resolution is hereby declared to be an emergency measure necessary for the preservation of public peace, health, and safety for the City of Uhrichsville and its inhabitants, and provided it receives the affirmative vote of two-thirds (2/3) of the members appointed or elected to Council, it shall take effect and be in force immediately upon its passage and approval; otherwise, it shall take effect and be in force from and after the earliest period allowed by law. The resolution is needed to express Council's support before the work starts and is let on mayor business projects.

III.

That it is found and determind that all formal actions of this Council concerning and relating to the passage of this resolution were taken in conformance with all applicable open meeting laws and that all deliberations of this Council and of any of its committees that resulted in those formal actions were in compliance with all legal requirements including open meeting requirements.
