RESOLUTION NO. 1795

TUSC CO BD ELECTION

A RESOLUTION PROVIDING FOR THE SUBMISSION OF THE AMENDMENT TO THE ELECTORS OF THE CITY OF UHRICHSVILLE AT ITS PRIMARY ELECTION ON MAY 2, 2017, DIRECTING THE CLERK OF COUNCIL TO FILE THIS RESOLUTION WITH THE TUSCARAWAS COUNTY BOARD OF ELECTIONS, AND. DECLARING AN EMERGENCY

WHEREAS, pursuant to Ordinance 2-17 of the City of Uhrichsville, this council amended to increase the municipal income tax rate 0.25% from 1.75% to 2% effective July 1, 2017 and subject to approval of the electors of the City of Uhrichsville;

WHEREAS, it is necessary to submit such amendment to the electors in accordance with ORC 718.04.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF UHRICHSVILLE, that:

- 1. Council has determined that it is necessary to increase the municipal income tax rate for the City of Uhrichsville .25% from 1.75% to 2% by amending the Codified Ordinances of the City of Uhrichsville set forth and adopted in 1973 (1%) and (3/4 %) in 1999 under Section 181 of the Codified Ordinances of the City of Uhrichsville..
- 2. As required by ORC 718.04, the amendment Ordinance 2-17 of the City of Uhrichsville shall become effective only if it is approved by the affirmative vote by the majority of the electors of the City of Uhrichsville, who shall vote on the question at the election on May 2, 2017.
- 3. The clerk of council is hereby authorized and directed to certify a copy of this Resolution and Ordinance 2-17 to the Tuscarawas County Board of Elections on or before February 1, 2017.
- 4. The clerk of council shall request that the Tuscarawas County Board of Elections include on the election to be held May 2, 2017 the question of approval of the amendment to Ordinance 2-17 passed January 26, 2017 to the voters of the City of Uhrichsville.
- 5. The form of the ballet to be given at the election on the question on the increase of the municipal income tax levy shall be substantially as follows in accordance with ORC 718.04(C):
 - SHALL THE ORDINANCE PROVIDING FOR A 0.25% INCREASE IN THE CITY OF UHRICHSVILLE MUNICIPAL INCOME TAX RATE FROM 1.75% TO 2% LEVY ON INCOME FOR THE PURPOSES OF THE STREET FUND, EFFECTIVE JULY 1, 2017, BE PASSED?
- 6. It is hereby found and determined that all formal actions of this council concerning and relating to the adoption of this resolution were adopted in an open meeting of this council and that all deliberations of this council, and any of its committees, that resulted in such

formal actions were in meetings open to the public and in compliance with the law.

7. This resolution is necessary to provide for and to accomplish the purposes herein set forth which are conductive to the health, safety and welfare of the citizens of the City of Uhrichsville, Ohio. For that reason, provided this resolution shall receive the affirmative vote of 3/4 of the members of council and the approval by the mayor, it shall be enacted immediately and shall be of immediate effect.
