

RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION

Rev. Code, Secs. 5705.19, .191, .192, .194, .21, .26

The MEMBERS OF COUNCIL of THE CITY OF UHRICHSVILLE, TUSCARAWAS County, Ohio, met in REGULAR session on the 9th day of MAY, 2019 at the office of UHRICHSVILLE CITY COUNCIL

- with the following members present: LINDA DAVIS ROBERT COTTRELL TERRY WARNER ERIC HARMON RONALD MILLER ROBERT BAKER BILL GRANDISON

Mr. Bill Grandison moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said CITY OF UHRICHSVILLE, TUSCARAWAS County, Ohio; therefore, be it

RESOLVED, By the MEMBERS OF COUNCIL of the CITY OF UHRICHSVILLE, TUSCARAWAS County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of THE CITY OF UHRICHSVILLE, OHIO

for the purpose of operating and maintenance of a public park, playground, playfield and for other recreational purposes (pursuant to Ohio Revised Code Section 755.18)

LEVY IS A RENEWAL at a rate not exceeding 0.5 mills for each one dollar of valuation, which amounts to \$0.05 (5 cents) for each one hundred dollars of valuation, for 5 YEARS Commencing in YEAR 2019 First due in Calendar year 2020
