A RESOLUTION TO ENTER INTO AN AGREEMENT WITH RUSH TOWNSHIP FOR THE PROVISION OF EMERGENCY MEDICAL SERVICES BY THE CITY OF UHRICHSVILLE TO RUSH TOWNSHIP

AMBULANCE SERVICE AGREEMENT

NOW come the parties hereto, Rush Township, Tuscarawas County, Ohio (hereinafter referred to as "Township") and the City of Uhrichsville, Ohio Fire Department (hereinafter referred to as "UFD") and hereby agree as follows:

- 1. UFD will provide emergency ambulance service to residents of Township in exchange for Township paying to UFD the sum of \$16.00 per capita for the first year of this Agreement (effective April 1, 2020) and the sum of \$17.00 per capita for the second year of this Agreement (effective April 1, 2021). Such amounts shall be paid by Township to UFD in equal monthly installments.
- 2. UFD shall be entitled to the collection and retention of fees for emergency service runs from the residents of Township who receive ambulance services from UFD.
- 3. UFD shall provide Township with monthly reports in regard to ambulance services provided to the residents of Township.
 - 4. The term of this Agreement will be good for a period of two years.
- 5. UFD is hereby designated as a primary provider of emergency medical services to the residents of Township during the term of this Agreement.
- 6. UFD shall act as an independent contractor and this Agreement shall not constitute UFD as an agent of Township in the operation of service of Township's affairs, and UFD shall hold Township, it's official agents, and employees, harmless from all claims for damages to person or property as a result of or in connection with the operation of this service by UFD.
