

RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION

Rev. Code, Sec. 5705.10, .191, .192, .194, .21, .26

The Council for the City of Urichsville, Tuscarawas County, Ohio, met in Regular session on the 24th day of July, 2014, at the office of City Council

- with the following members present: Cathy Cottis, Bob Baker, Linda Davis, Bill Brandon, Terry Warner, Joe Peterson, Gayle Mick

Mrs Cottis moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said City of Urichsville, Tuscarawas County, Ohio; therefore be it

RESOLVED, by the Council of the City of Urichsville, Tuscarawas County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of City of Urichsville

for the purpose of operating and maintenance of a public park, playground, playfield and for other recreational purposes

at a rate not exceeding fifty one hundredth mills for each one dollar of valuation, which amounts to 05 cents

for each one hundred dollars of valuation, for 5 years, commencing in year 2014, first due calendar year 2015.

which is a renewal of a .5 mill tax

RESOLVED, That the Clerk of this RESOLUTION 1714
be and he is hereby directed to certify a copy of this Resolution to the Board of Elections,
Tuscarawas County, Ohio,

and notify said Board of Elections to cause notice of election on the question of levying said tax to
be given as required by law.
