M. R. Bob Baker moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said

City of Uhrichsville, Tuscarawas County, Ohio; therefore be it

RESOLVED, by the City Council of the City of Uhrichsville, Tuscarawas County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of City of Uhrichsville for the purpose of providing ambulance service emergency medical service OR BOTH.

at a rate not exceeding 2.85 mills for each one dollar of valuation, which amounts to \$0.285

for each one hundred dollars of valuation, for 5 years, commencing in year 2015, first due calendar year 2016.
