UHRICHSVILLE CITY COUNCIL Thursday, September 10, 2020

Council President Robert Cottrell called the meeting to order at 7:00 p.m.

ROLL CALL showed the following members present: Mr. Zucal-yes; Mr. Baker-yes; Mr. Miller-yes; Mr. Harmon-yes; Ms. Myers-yes; Mr. Huff-yes; Mr. Fox-no.

The Pledge of Allegiance was led by Council Clerk Trisha Addison.

Council President Robert Cottrell asked for a motion to excuse the absence of Councilman Matt Fox. A motion was made by Ms. Myers seconded by Mr. Zucal. ROLL CALL: Ms. Myers-yes; Mr. Zucal-yes; Mr. Huff-yes; Mr. Baker-yes; Mr. Miller-yes; Mr. Harmon-yes.

Council President Robert Cottrell asked for a motion to accept the Council Meeting Minutes from August 27, 2020. A motion was made by Mr. Huff, seconded by Mr. Miller. ROLL CALL: Mr. Huff-yes; Mr. Huff-yes; Mr. Zucal-yes; Mr. Baker-yes; Mr. Harmon-yes; Ms. Myers-yes.

The meeting was turned over to Councilperson Amy Myers and the Special Contact/Special Recognition Committee consisting of Ms. Myers (head), Mr. Harmon and Mr. Miller. They are honoring businesses and employees of the City that have given back to the City.

- Presented Joanne "Jody" Dunlap with a Proclamation of Appreciation from the City of Uhrichsville for her service to the City including her employment as Auditor for the City of Uhrichsville beginning June 11, 1970 and retiring November 1, 2014.
- Presented Rod and Linda Smith of Rod's Donut Shop with a Proclamation of Appreciation stating Rod's Donut Shop was opened June 28, 1976 in the City of Uhrichsville and have built a wellestablished business and stating the City's gratitude for their many years of service.

ADMINISTRATIVE REPORTS:

Mayor Mark Haney:

- Handed out to Council copies of all the PIN notices that the City has put out since the police department took over.
- Received letter stating that we did not receive the COP grant.
- Paving is done and have been focusing on striping and cross walks. Came in under budget at \$259,000.00 including additional streets completed. Newton Paving did an excellent job.
 Thanked the street department for saving the City money by doing traffic control. He's already looking at next year's paving plan.
- Work at the city building is being done including duct work cleaned, air cleaners, fire bays are being cleaned as part of the COVID program.
- Have been discussing how to spend the COVID money. We have an issue separating our street department workers while traveling and are looking at purchasing two pickup trucks and spending up to \$50,000.00 each, an unmarked car for the police department spending up to \$30,000.00, and upgrading the software in the computers in the police cruisers and spending up to \$17,000.00. We also need storage for the COVID supplies. Mr. Ong added that anything over \$10,000.00 needs Council's approval. The Fire Department is interested in a Power Cot that sanitizes at a cost of around \$50,000.00. \$162,000.00 and \$82,000.00 have to be encumbered by October 15, with checks issued by December 28. The Auditor has encumbered \$88,000.00

- and has spent \$6,000.00. If we are awarded the additional \$191,000.00, we have until November to encumber those funds.
- Mr. Harmon asked about the other towns that were making COVID purchases. Steubenville bought two ambulances, Chillicothe and Caldwell are buying trucks. Asked Law Director and Auditor if they were okay with spending this money. Ms. Pearch felt this was an opportunity to separate the workers in their vehicles and would not hinder projects in other departments. Mr. Harmon's only comment is that we might have this vehicle for 10 to 15 years and are there plans to replace the vehicles after that? Mayor Haney said that they will last how long we take care of them. Mr. Harmon wants it to be clear we are using CARES Act money and not General Fund money to make these purchases.
- Mr. Zucal added that he would like to see something in writing to look at and consider before spending taxpayers' money. He would prefer spending on cleaning supplies, etc. first. Mayor Haney said that those items have been looked at and purchased first. Mr. Ong said that he could put something together, but this is a permissible expense.
- A Motion was made by Mr. Baker, seconded by Mr. Huff to purchase a pickup truck for the street department spending up to \$50,000.00, conditioned upon the Law Director providing written verification that this is a permissible expense. ROLL CALL: Mr. Baker-yes; Mr. Huff-yes; Mr. Miller-yes; Mr. Harmon-yes; Ms. Myers-no; Mr. Zucal-yes.
- A Motion was made by Mr. Baker, seconded by Mr. Huff to purchase a second pickup truck for the street department spending up to \$50,000.00, conditioned upon the Law Director providing written verification that this is a permissible expense. ROLL CALL: Mr. Baker-yes; Mr. Huff-yes; Mr. Miller-yes; Mr. Harmon-yes; Ms. Myers-no; Mr. Zucal-yes.
- A Motion was made by Ms. Myers, seconded by Mr. Miller to purchase an unmarked police cruiser spending up to \$30,000.00, conditioned upon the Law Director providing written verification that this is a permissible expense. ROLL CALL: Ms. Myers-yes; Mr. Miller-yes; Mr. Huff-yes; Mr. Zucal-yes; Mr. Baker-yes, Mr. Harmon-yes.
- A Motion was made by Mr. Huff, seconded by Ms. Myers to purchase software for the computers in the police cruisers and spending up to \$17,000.00 conditioned upon the Law Director providing written verification that this is a permissible expense. ROLL CALL: Mr. Huff-yes; Ms. Myers-yes; Mr. Zucal-yes; Mr. Baker-yes; Mr. Miller-yes; Mr. Harmon-yes.
- A Motion was made by Ms. Myers, seconded by Mr. Miller to purchase a Power Cot spending up to \$50,000.00 conditioned upon the Law Director providing written verification that this is a permissible expense. ROLL CALL: Ms. Myers-yes; Mr. Miller-yes; Mr. Huff-yes; Mr. Zucal-yes; Mr. Baker-yes; Mr. Harmon-yes.
- Council President asked Mayor Haney to provide a list of items for the agenda to the Council Clerk by the Monday before the meeting so that Council has a chance to review items before the meeting. Mayor Haney will give us what he has by Monday.

City Services Director Belle Everett:

Absent.

Law Director James J. Ong:

- Asked for guidance from Council, in May he provided a Memo regarding the use of internet sales
 for unneeded equipment. If Council wants to go through with that he could provide the
 necessary Resolution, or Council could assign it to committee. Ms. Myers said that was
 approved at the last meeting by Motion. Mr. Ong said a formal Resolution is needed and he
 would prepare one.
- Mayor Haney said we will be getting rid of the old boom truck and is there a preference on how to get rid of it? Mr. Ong said we would enter into a contract with the expectation that everything goes to this company to do, but we are not under contract now. Mayor Haney said that we have

done it by sealed bid in the past. A Motion was made by Mr. Zucal, seconded by Mr. Harmon to advertise for sealed bids for sale of the old boom truck, with Council having the right to accept or reject all bids, with all bids being in by the second meeting in October, with the money going back to the street fund. ROLL CALL: Mr. Zucal, Mr. Harmon, Mr. Baker-yes; Mr. Miller-yes; Ms. Myers-yes; Mr. Huff-yes.

- Updated Council that he still awaits results of the lien search on the properties Council designated for demolition. He wants to make sure we don't have an issue with Tax Ease. Once the lien search is back, Council has authorized the foreclosure sales on those. The County will be paid the \$2,500.00 per parcel to start the process under the Land Reutilization Program. If the property does not sell after two attempts at sheriff sale, then it will be deeded over into the name of the City, all of the liens will be wiped out, and the City is free to sell it to whomever. Ms. Myers asked if investors have to wait until the City owns and they do.
- Asked that Council go into Executive Session at the end of the meeting to discuss pending litigation.

Auditor, Julie Pearch:

- Urged everyone to document requests for CARES Act money.
- Had an audit of the Jedd Fund that has been dormant for years because we don't have a
 retention policy and we records policy. Mr. Harmon said there is a board but they do not meet.
 He has contacted everyone on the committee but there have not been any meetings.

Mr. Ong said the City needs to negotiate with all departments to have a similar policy. Mr. Zucal mentioned that while budgeting for 2021, we should look at Clemmons & Nelson in Columbus to do a draft personnel policy and get a price from them. Mayor Haney added that we need to know when someone is hurt at work, it is common sense to report it right away.

Mr. Ong asked for guidance from Council as to proceeding with an investigation of Mr. Milligan's property. There is a line that runs through his property. Mr. Milligan believes it is an old storm sewer line that runs through his property. Mr. Galbreath says the City has never maintained that area and no records have been found. Mr. Galbreath's concern is if it is a storm sewer, why is there a line running directly from Mr. Milligan's house to the storm sewer. Mr. Milligan is willing to sign a waiver allowing the City to come onto his property and he's requesting that the area be cameraed to see how far it goes and if it is an old storm sewer line. Mr. Milligan should cover half of the cost and if the findings would be inconclusive he would then have to reimburse the City for the City's one-half of expenditure. If it is a line and the City decides to take it over, they would issue an order directing him to disconnect the line from his home. The cost would be around \$2,000.00 for the camera for the day. Council directed Mr. Ong to prepare an agreement to review.
