

**RESOLUTION NO. 1907**

**A RESOLUTION TO ENTER INTO AN AGREEMENT WITH RUSH TOWNSHIP FOR THE PROVISION OF EMERGENCY MEDICAL SERVICES BY THE CITY OF UHRICHSVILLE TO RUSH TOWNSHIP**

WHEREAS, the Rush Township Trustees have requested that the City of Uhrichsville Fire Department provide emergency medical services to the residents of Rush Township.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF COUNCIL OF THE CITY OF UHRICHSVILLE as follows:

SECTION 1. The City of Uhrichsville shall immediately enter into an Agreement with **Rush Township** in regard the City of Uhrichsville Fire Department, for a fee, providing emergency medical services to the residents of Rush Township (a copy of such agreement attached hereto).


SECTION 2. The Mayor of the City of Uhrichsville is hereby authorized and directed to execute such agreement on behalf of the City of Uhrichsville.





## AMBULANCE SERVICE AGREEMENT

NOW come the parties hereto, **Rush Township, Uhrichsville County, Ohio** (hereinafter referred to as "TOWNSHIP") and the **City of Uhrichsville, Ohio Fire Department** (hereinafter referred to as "UFD") and hereby agree as follows:

1. UFD will provide emergency ambulance service to residents of TOWNSHIP in exchange for TOWNSHIP paying to UFD the sum of **\$17.50** per capita for the **first year** of this Agreement (effective **April 1, 2022**), the sum of **\$18.00** per capital for the **second year** of this Agreement (effective **April 1, 2023**) and the sum of **\$18.50** per capital for the **third year** of this Agreement (effective **April 1, 2024**). Such amounts shall be paid by TOWNSHIP to UFD in equal monthly installments.
2. UFD shall be entitled to the collection and retention of fees for emergency service runs from the residents of TOWNSHIP who receive ambulance services from UFD.
3. UFD shall provide TOWNSHIP with monthly reports in regard to ambulance services provided to residents of TOWNSHIP.
4. The term of this Agreement will be for a period of three (3) years.
5. UFD is hereby designated as the primary provider of emergency medical services to the resident of TOWNSHIP during the term of this Agreement.
6. UFD shall act as an independent contractor and this Agreement shall not constitute UFD as an agent of TOWNSHIP in the operation of service of TOWNSHIP's affairs, and UFD shall hold TOWNSHIP, its officials, agents, and employees, harmless from all claims for damages to person or property as a result of or in connection with the operation of this service by UFD.
